DEI Conversation with School Leaders

Anwar Abdul-Rahman, principal at Explore Upper, read a prepared statement to the Board drafted by Black leaders from Explore addressing the steps the network and its senior leadership should take to dismantle systems of oppression and white supremacy culture. The board thanked Anwar and the Black leaders for their statement, and acknowledged the need to continue this conversation at future board meetings.

COVID-19 Update & Contingency Planning

Carrie Mauer & Christina Froeb shared updates around summer and fall planning as they related to the impact of COVID-19 and the contingencies being planned for. This included:

- Updates on summer academic and engagement opportunities at each school
- Details on the remote professional development taking place over the summer
- Updates on the plan for a remote start on August 26th for all students except kindergartners who will start on the 24th.
- Updates on thinking around implementing a hybrid model of in-person and remote instruction.
- Details on new guidance from the state
- Details on how schools will be incorporating trauma-informed instruction
- Updates on how staff and families are feeling about returning to school
- Details on what instruction and assessments will look like.

Board members asked questions about the timeline for information from the state, what the schedule could look like for families, staff member concerns with returning, and about the additional tech needs of our community for remote learning.
