## **CEO Update**

Karen Annette Francois, CEO, updated the board on recent math interim assessment data previewed with the accountability subcommittee ahead of the state math exams on May 2<sup>nd</sup> and 3<sup>rd</sup>. The Board discussed the key actions the network took throughout the year and the adjustments made to improve mathematics instruction in response to interim assessment data from earlier in the year. The Board also discussed additional ways to review the data, including looking at cohort data. In addition, Karen Annette shared reflections from the ELA state exam, updated the board on how the network's 8<sup>th</sup> graders did with the high school placement process, and shared enrollment data coming out of the lottery season. The Board discussed enrollment trends and asked what marketing efforts are yielding more applications.
