The shared priority for 2023-24 is Developing our Expertise, Elevating Student Learning. Karen Annette shared how the priority will influence how the network designs and leads PD over the summer. Board members discussed what success against the priority looks like at the end of the school year. Finally, Karen Annette updated the Board on the charter renewal process and timeline.

#### Finance Update & FY 24 Budget Previews

Ashley Dickens, Managing Director of Finance, shared an ESI and ECSB finance update including a review of the Q3 financials for both ECSB and ESI, as well as a formal high-level preview of the FY 24 proposed budget. Ashley also shared an update on the ESI Audit which included a clean opinion. The board asked questions around percent of students receiving services and anticipated enrollment numbers for the fall as they impact budgeting.
